





DELIVERY OF NON-FORMAL TRAINING PROGRAMS FOR CIVIL SOCIETY ORGANIZATIONS

TERMS OF REFERENCES

1. ABOUT THE ACTIVE PROJECT

Project "ACTIVE - Accessible Communication Towards Inclusion of Vulnerable and Excluded persons on Western Balkans" aims at developing the concept of inclusive and accessible communication for disadvantage people in five countries of the Western Balkans (Albania, Bosnia and Herzegovina, Montenegro, Kosovo and Serbia). The local project partners belong to the Caritas network and have worked together on different projects, sharing common values, joint mission and strategies.

One of the specific objectives of the project implies that disadvantaged and excluded people in the project regions make use of the access to relevant information in easy-to-read native languages and accessible native language. As a measure to achieve this objective, training of 30 future multipliers on accessible communication, according to the ToT concept, is planned.

2. OBJECTIVE, RESULTS AND TASKS OF THE SERVICE

Members of the local project teams as well as 20 other participants (media workers, communication officers, pedagogues or other expert/service providers) will receive an extensive training following train-the-trainer concept. The aim is to acquire in-depth knowledge about Accessible Communication. Training will provide knowledge on verbal and written communication, with special focus on design, visuals, usage of font types and colors, creation of accessible website and accessible events organizations. Based on this, training participants will receive support to develop the rules and recommendations for easy-to-read texts. Finally, they will acquire the skills required for conducting further workshops to train. Training will be organized in 5 modules per language group by local specialist and specialists from Austria and Germany.

General tasks of selected service providers:

- To create detailed implementation plan according to tasks of the service
- To create all presentation and other material for the training (exercises, examples etc.)
- To implement training
- To create final report of the trainings

Language: Training will be divided according to the two language groups - Serbian/Bosnian/Croatian/Montenegrin and Albanian language. Trainers will hold training in mother language.





3. TRAINING INFORMATION

Training will be delivered in hybrid format where participants from the same country will be gathered together on one place and follow the training using online platforms. At least 6 participants from each country should be included in training. First module of the training will be delivered in September 2022. Training is organized in 5 modules per language group:

5. HOW TO APPLY?

• Candidate's CV, which clearly indicates experience, references in performing similar tasks and knowledge of the required topic. Legal entities should also submit the CV of the person (s) who will work on the development of the curriculum.

6. CRITERIA FOR SELECTION OF CANDIDATES

The Project committee will consider all applications and will decide on the selection of candidates. A written report on the selection of contractors will be sent to all candidates who apply for the competition. During the analysis of applications, the Committee will consider the relationship between all the above criteria. The basic criteria for selection are:

- Administration (eliminatory criteria): application sent in time, electronically and all documents submitted.
- Knowledge relevant to the topic: 70% of the total points
- Price for service: 10% of the total points
- Experience in trainings delivery and/working with people with disabilities: 20% of the total points

Conflict of interest: This call is not open to natural or legal entities who are in a potential conflict of interest, or persons who may in any way affect the process of objective decision-making. Project team reserve the right to reject an application that is found to be in a potential conflict of interest in accordance with domestic legislation.
